

ABOUT 5 FURLONGS. (Turf) (.544) NEED FOR SPEED S. Purse \$50,000 (includes \$50,000 Other Sources) FOR THREE YEAR OLDS AND UPWARD. No nomination fee. \$250 to enter. \$250 to pass the entry box. Supplementary nomination of \$1,500 due at the time of entry (includes entry and starting fees). \$50,000 Guaranteed of which 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Three year olds:119. Older:123. Non-winners of \$30,000 in 2017 allowed 2lbs; non-winners of two races other than maiden, claiming or starter in 2017 allowed 4lbs; such a race in 2017 allowed 6lbs. In the event that more than twelve(12) pass the entry box, preference will be given to the horses with the highest earnings in 2016-2017. Different owners have equal draw according to earnings. The second part of a same owner entry will have no consideration over a single interest. Failure to draw into the race cancels all fees. Nominations closed Saturday, August 26, 2017 with 43 nominees. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at Five Furlongs).
