INDULGENT broke forwardly placed and retained its position, was coaxed along prompting the pacesetter from the three path, continued along under the same scenario all the way to the end of the bend, got cued up and then turned loose spinning into the lane, out-fought the nemesis to clearly emerge in front by the eighth pole, but with the second place finisher bearing down hard to the outside, drifted out slightly in the final stages but dug in with good determination nevertheless to preserve the decision. HIGHWAY STAR away well, took up residence in the pocket, was lightly hand urged keeping watch on the front runners, slipped out into path three as three-quarters was being completed, stepped into the stretch and had the pilot go to work, closed in enough to loom boldly by midstretch, came out slightly and briefly with approximately a sixteenth remaining, quickly corrected course and continued onward in a willing manner but got staved off. VERVE'S TALE went about along the backstretch from between opponents pulling on the bit, got spotted into the three path by the top of the turn, pursued the ones to catch from midpack, was angled five wide into the stretch, mustered up a mild response sufficient enough to claim the show award. GOING FOR BROKE unhurried taking up the chase from the two path, was one path farther off the rail at the top of the lane, made no impact. LUCY N ETHEL contended with the winner while racing towards the two path, saw that one narrow in as the third fraction was about to posted on the board and got called upon, relinquished for good soon afterwards, remained a forward factor until the completion of the trip through the furlong grounds before backing away. FLORA DORA four wide and roused on the turn, lacked the needed response. JAMYSON 'N GINGER took the inside route, was called upon leaving the five-sixteenths marker, failed to muster up the desired response and faltered.
