BABYBLUESBDANCING tracked the pace on the outside going three wide around the turn, took over at the top of the stretch and drew off and was ridden out under the line. COUNTESS ST MICHEL had a comfortable lead, blew the turn a bit coming into the stretch causing SHEZAHOTMAMA to check but COUNTESS ST MICHEL was not bothered then had a steady fade down the lane regardless. SHEZAHOTMAMA bobbled at the start but quickly recovered, stalked the pace then began to run between horses but had to check near the three sixteenths pole as COUNTESS ST MICHEL was bearing out losing all her momentum. ROMANCIN N DANCIN lunged at the start and was caught trailing the field early, was full of run coming up at the quarter pole but flattened out. KALISPELL lacked the needed rally. SPRING CITY GAL ran towards the rear going four wide, swung even wider at the top of the stretch but had no response. KONZA KHROME tracked the pace between horses going three wide then had no response. HOPE N WISHES showed mild early speed. STEWARDS DISALLOWED THE CLAIM OF FOUL BY THE RIDER OF SHEZAHOTMAMA AGAINST COUNTESS ST MICHEL.
