SOME SAY SO, urged to gain the lead while angling to the inside, dictated the pace on a comfortable margin under light rating to the far turn, then held sway through the lane under firm handling to prove best. FIRST HUNTER was rated between foes just off the second flight racing to the first turn, angled to the rail entering the backstretch, saved ground to upper stretch, then shifted three wide in late stages while producing a solid late response to close the gap while prevailing for the place honors. HONEY'S SOX APPEAL angled to the inside early tracking just off the pacesetter under light reserve, was urged to advance just outside the leader racing into upper stretch but had no final kick. SWEET TANGO, forwardly placed tracking just off the pacesetter racing to the far turn, faded into upper stretch. THUNDER AND HONEY ducked inwards in the opening stages making contact with FIONA CAT, was righted to track off the second flight outside foes to the far turn but lacked a rally. FIONA CAT, clipped, then steadied in the opening stages, settled last near the inside, swung out six wide into upper stretch but made no impression. STELLABRINI tracked the leaders three, then four wide to the far turn and gave way into upper stretch. SASSY PRANCE settled along the rail in early stages and offered no rally. BLAZING ANGEL was settled into stride off the inside racing to the backstretch but dropped out early.
