PROFOUND MOMENT pressed the pace of CITIZEN KITTY while racing three-wide, moved up to engage that rival nearing the five-sixteenths marker, vied into deep stretch and drew clear through the final yards. CITIZEN KITTY broke sharply to set a pressured pace from the inside, responded when challenged by the winner nearing the five-sixteenths pole, vied but could not match strides with that foe late. PERHAPS A PIE was bumped at the start, showed no early speed, raced three-wide through the turn and finished with a steady bid. PROTECTIVE SHIELD hopped at the start, raced just off the leaders early, moved four-wide through the turn and lacked the needed late response. B C Z MIDDLETON was void of early speed, raced four-wide through the turn and failed to menace. PRINCESS KENNEDY lacked early foot, raced six-wide through the turn and did not reach contention. MY HEART GOES ON was bumped at the start and bobbed, moved up quickly to press the pace from the inside and weakened after going three furlongs.
