SHADED was inside and being sent up trying to slipped through the inside on the run down the backstretch, was shut off and forced to steadied sharply nearing the half mild pole, taken up sharply then came again in the stretch but came up empty in late stretch. IMMA WILD BLING chased then early pace while three wide into eh turn then raced evenly in the stretch. TOO MUCH GONE raced four wide on the turn then was no threat in the stretch. MY EXPECTATIONS was inside and trailed. A claim of foul was lodged by the rider of SHADED against the rider of CONTARYTOODINARY for interference on the backstretch. After reviewing the film's, no action was taken.
