CLASS INCLUDED away well and tracked the dueling leaders one from the rail through the second turn, continued from a striking position in the run down the backside, engaged the leaders approaching the final turn and quickly took command entering the final turn and drew clear. HEIDI MARIA stalked the pace while saving ground from along the inside into the second turn, tipped off the rail for a clear run down the backstretch, advanced four wide nearing the final turn, rallied three wide through the turn, was no match for the winner in the stretch, but battled gamely to hold the place. WANDO WOMAN settled well off the early pace while racing just off the rail, rallied four wide entering the final turn, and closed willingly through the stretch to just miss the place. P. S. TOUCH DOWN broke sharply and dueled for the lead from the onset while racing one from the rail, battled down the backstretch from the outside of TERLANI, was collared by CLASS INCLUDED approaching the final turn, and faded over the final furlong. ORCHID'S SILVER stalked the pacesetters through the first turn racing one from the rail, continued to stalk the dueling leaders through the second turn racing three wide, rallied two from the rail through the final turn and was only able to post a mild late bid. TERLANI away alertly and vied for the lead from along the rail entering the first turn, battled through the second turn and down the backside from the inside of P.S. TOUCH DOWN, but had little response when tackled by CLASS INCLUDED nearing the final turn, and weakened. CASTINETTE DANCER unhurried early while dropping back to trail, and was unable to make any kind of impact.
