Free nominations closed on Friday, February 24, 2017 with 14. Supplementary nominations of \$1,500 are due at entry time. \$500 to start. The added monies and all fees to be divided 60% to the winner, 20% to second, 12% to third, 6% to fourth and 2% to fifth. Weight 124 lbs. Non winners of \$40,000 since September 15 allowed 2 lbs. Non winners of \$30,000 since January 1 allowed 4 lbs. (Maiden, claiming and starter races not considered). (Rail at 10 feet).

STORMY LIBERAL pressed the pace four wide then stalked outside, re-bid three deep leaving the hill and outside a rival into the stretch, took the lead in upper stretch, drifted in despite left handed urging in midstretch while inching away, drifted out from the whip in deep stretch and held on gamely. PERFECTLY MAJESTIC broke a bit slowly, chased off the rail, came out leaving the hill and five wide into the stretch, drifted inward in midstretch and past midstretch, bid outside the winner in deep stretch and just missed. DANZING CANDY had good early speed and dueled inside, fought back into the stretch, steadied in tight in midstretch then came out and held third. FABOZZI stalked a bit off the rail then between horses, came out some leaving the hill and three wide between foes into the stretch and was edged for the show. CLEVER ROYAL chased outside, came out leaving the hill and five wide into the stretch and lacked the needed rally. FOREST CHATTER saved ground stalking the pace, continued inside in the stretch and weakened. FOREVER JUANITO pressed the pace three deep between horses then stalked outside, was in a bit tight leaving the hill, came four wide into the stretch and also weakened. NO SILENT bobbed at the start, dueled between horses then outside a rival, continued between foes leaving the hill, was in a bit tight onto the dirt crossing and weakened in the drive. The stewards conducted an inquiry into the run through midstretch but made no change when they ruled the trouble to DANZING CANDY did not cost that one a better position. A claim of foul by the rider of the runner-up against the winner for alleged interference in deep stretch was not allowed by the stewards, who ruled the videotape failed to substantiate the claim. Rail on hill at 7 feet.
