

6 FURLONGS. (1.08) 10TH RUNNING OF THE PRIORRESS. Grade I. Purse \$300,000 FOR FILLIES THREE YEARS OLD. No nomination fee. \$3,000 to pass the entry box. A supplemental nomination fee of \$6,000 in addition to the entry fee will be accepted at any time prior to entry. All starters including supplemental nominees will receive a \$1,500 rebate. Any filly that competes in both the Priorress and the Test will have their entry fee waived for the Test. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 122 lbs. Non-winners of \$60,000 twice allowed 2 lbs.; \$60,000; or \$45,000 in 2012, 4 lbs.; \$30,000; or two races, 6 lbs. (Maiden, claiming, starter, restricted and restricted stake races not considered in allowances). Trophies will be presented to the winning owner, trainer and jockey. EMMA'S ENCORE lagged along taking the inside route down the backstretch, was asked to pick up interest while angling outward midway on the turn, closed the gap during the remainder of the run around the bend, was already under strong handling spinning three wide into the lane, continued to rally in earnest after being straightened away, came relentlessly leaving the sixteenth marker, wresting away the decision from JUDY THE BEAUTY right on the finish line. JUDY THE BEAUTY lost her footing at the start, bobbling ever so slightly, became the main pursuer departing the backstretch, doing so while two wide, got asked for run as the field headed into the stretch, cut into AVAVE KISS' margin steadily throughout the stretch run, led for a few strides in the final seventy yards only to get nipped on the wire. AGAVE KISS quickly established control, showed the way with no other latched on from the two path while making her way down the backstretch, inched her way closer to the rail at the half mile pole, although still kept at a slight distance off of it, was well rated for the opening half, rider aboard with a snug grip on the reins almost until the quarter pole, was asked for a response soon after settling into upper stretch, saw the margin dwindle down readily leaving the furlong marker, got overhauled by the top pair past the sixteenth pole and had to settle for the show. JAZZY IDEA four wide at the half mile pole, remained well off the inside around the turn, was under a drive entering the stretch, made up only a minimal amount of real estate with a fairly even finish. LIVI MAKENZIE saved ground, was asked for some run by the five-sixteenths pole, came up empty. TU ENDIE WEI followed AGAVE KISS over to the inside, tucking along the rail around the seven-sixteenths pole, kept a watchful eye on that opponent until upper stretch and faltered.
