TWICE THE APPEAL was allowed to settle early racing off the inside, moved up into the second turn, angled four to five wide, placed a bid to be on even terms with ASTROLOGY at the sixteenth pole, dug in the final yards and inched away to be best. ASTROLOGY stalked the early leaders four wide, vied into the second turn, gained a short lead at the eighth pole, was challenged nearing the sixteenth pole, battled gamely but was unable to last and outfinished. RULER ON ICE was unhurried early racing along the inside, lost some ground angling out three wide in the second turn, drifted out five wide at the quarter pole and closed late to gain the show. IT'S MY PARTY was off slow early racing along the inside, rallied angling out five wide at the quarter pole and closed willingly in deep stretch. BEER MEISTER was void of early speed, went seven wide into the stretch and showed some effort late. NACHO SAINT prompted the early pace from the outside, tired after a half and gave way. FUSA CODE was outrun early racing off the inside, sustained a brief bid four wide then weakened. R SKYDIVER was forwardly placed early along the inside, angled four wide nearing the three sixteenth pole then faded in the lane. SUPREME RULER was jostled at the break to get away slow and was not a factor. BEHOLD DE BUY went three to four wide and lacked a closing response. SINAI moved up between foes to set the early pace drawing clear while saving ground then stopped after a half.
