A Supplementary Nomination fee of \$1,500 may be paid by Saturday, May 11, 2024 which includes entry and starting fees. Original Nominees to pay \$300 to pass the entry box and \$450 additional to start. All fees to be paid to the Horsemen's Bookkeeper prior to the start of the race. With \$75,000 Guaranteed to be divided 60 percent of all monies to the winner, 20 percent to second, 10 percent to third, 5 percent to fourth, 3 percent to fifth and 2 percent divided equally among the remaining finishers. Weights: Sunday, May 12, 2024. This Handicap will be limited to fourteen (14) starters with no also eligibles. Starters to be named through the entry box by the usual time of closing. JOURNEYIST chased the pace from the rail and lacked a response when called upon. WHITE LIES was not a threat. RAINY MOUNTAIN was not a factor.
