No nomination fee, \$150 to pass the entry box and an additional \$100 to start, with \$100,000 Guaranteed. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$625 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, the purse will be divided, 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Wednesday, May 8 Starters to be named through the entry box by the usual time of closing. Trophy to the winning owner. NOTE: This race will be limited to 12 starters. If more than 12 horses pass the entry box preference will be given to those with the highest weights. Second preference will be lifetime earnings. Entry fee only will be refunded if failure to draw into the race. Nominations Closed on Wednesday, May 1, 2024 with 26 Nominations.**

REFLEX stalked the early pace in the five path, bid at the seven-sixteenths pole, dueled, was clear and held sway under steady urging. RIGOBERTO was squeezed back at the start, stalked the pace in the four path, bid in early stretch but couldn't get to the winner. CRINGE stalked the pace inside, steadied, came out and checked at the seven-sixteenths pole, raced inside, took up at the quarter pole, then gained the show spot late. BOOMING stalked the pace in the three path, shifted to the rail at the three-sixteenths pole, then had no late bid. UNBRIDLED SLOPE was bumped at the start, checked at the nine-sixteenths pole, angled three wide on the turn and had a mild late bid. TIZ EDDIE stalked the pace and took up at the seven-sixteenths pole. KINGSBURY ROAD improved position late outside. HOOSIER DADDY NOW stalked the pace between and was checked at the half-mile pole. THEO'S PROMISE was checked early. OIL MAN stalked the pace in the five path and was checked at the three-eighths pole. TACKLIN FUEL was clear early, then gave way at the quarter pole. INCLINED was through early and steadied at the half. FOLLOWING A STEWARDS' INQUIRY AND AN OBJECTION BY THE RIDER OF HOOSIER DADDY NOW, CRINGE WAS DISQUALIFIED AND PLACED EIGHTH.
