6 FURLONGS. (1.074) SPEIGHTSTOWN SPRINT S. Purse \$100,000 (PLUS UP TO \$15,000 Open ATB) FOR THREE YEAR OLDS AND UPWARD. No nomination fee. \$500 to pass the entry box and an additional \$500 to start. Supplemental nominations may be made at time of entry for \$1,500 and shall include all fees. After payment of 1.5% of the purse to all owners finishing sixth through last, 60% of the remaining purse shall be paid to the winning owner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. If less than five horses start, the remaining purse will be distributed to the winning owner. Startersto be named through the entry box by the usual time of closing. Weights: Three Year Old, 121 lbs. Older, 124 lbs. Non-winners of \$25,000 in 2024 allowed 2 lbs.; Non-winners of \$15,000 since November 27, 2023 allowed 4 lbs.; Non-winners of \$15,000 in 2023—2024 allowed 6 lbs. Maiden and claiming races not considered in weight allowances. Total earnings in 2023—2024, as determined by the information provided by Equibase Company, will be used in determining the order of preference. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry of the entry fee. A trophy will be presented to the winning owner.

MINNESOTA READY was bumped on both sides, saved ground along the inside, came out four wide leaving the turn and surged down the lane and was up at the wire to prevail. TAPE TO TAPE was away well to duel with an inner foe, disposed of that foe on the turn, was challenged by another on the outside, dug in gamely to take command at the eighth pole then was caught at the wire by MINNESOTA READY. MISH was bumped at the start, then pursued the pace while three wide, was urging on the turn, came out three wide to bid in the stretch but it was not enough in the end. AUGUSTA MELODY pursued the pace while four wide, was moving up on the far turn to duel with an inner rival briefly, then gave way in the stretch. MARSALIS was impeded at the start and was no menace. GUNFLASH was no factor. RUGGS veered outwardly and bumped foe, then dueled with an outer foe into the turn, was in tight, steadied at the five sixteenths pole then flattened out. MAHOMY pulled up shortly after the start and was vanned off.
