6 FURLONGS. (1.074) MEMORIAL DAY SPRINT S. Purse \$100,000 (PLUS UP TO \$15,000 Open ATB) FOR FILLIES AND MARES, THREE YEAR OLDS AND UPWARD. No nomination fee. \$500 to pass the entry box and an additional \$500 to start. Supplemental nominations may be made at time of entry for \$1,500 and shall include all fees. After payment of 1.5% of the purse to all owners finishing sixth through last, 60% of the remaining purse shall be paid to the winning owner, 20% to second, 11% to third, 6% to fourth, 3% fifth. If less than five horses start, the remaining purse will be distributed to the winning owner. Starters to be named through the entry box by the usual time of closing. Weights: Three Year Old, 120 lbs. Older, 123 lbs. Non-winners of \$25,000 in 2024 allowed 2 lbs.; Non-winners of \$15,000 since November 27, 2023 allowed 4 lbs.; Non-winners of \$15,000 in 2023-2024 allowed 6 lbs. Maiden and claiming races not considered in weight allowances. Total earnings in 2023-2024, as determined by the information provided by Equibase Company, will be used in determining the order of preference. The field will be limited to fourteen starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner.

SPIRIT WIND stalked the pace while three wide down the backstretch, then inched up to gain command at the top of the turn then drew clear in the late stretch to prevail in the end. ACCOMPLISHED GIRL pressed the pace from the inside then settled back on the turn to save ground, rallied in the upper stretch but it was not enough to claim victory in the end. MY FRIEND AMY was unhurried early, then came out six wide leaving the bend and rallied mildly in the stretch and was up for third place. RECLUSIVE was allowed to settle along the inside, then bid mildly in the late stretch just missing the show prize in the end. ADALINE JULIA was no menace. NON VIOLENCE was off slowly and no threat. PALACEIN set the pace while two wide, was over taken at the top of the turn, then flattened out in the stretch. MAJESTIC WAYS raced mid pack while two wide, then bid on the turn before giving way in the stretch. APPROPRIATED FUNDS was flat throughout and needed rally.
