1 MILE 70 YARDS. ( 138<sup>3</sup> ) SERENA'S SONG S. Purse \$100,000 FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$100 each, which should accompany the nomination, \$500 to pass the entry box and \$1,000 to start. \$2,000 supplemental nominations were made at time of entry, Thursday, May 9, 2024, which includes all fees. The winner to receive \$60,000, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to sixth through last. Weights: Three-Year-Olds: 121 lbs.; Older: 124 lbs. Non-winners of a sweepstakes in 2024 allowed 2 lbs.; \$60,000 once since February 1, 2024, 4 lbs.; \$40,000 once in 2024, 6 lbs. (Maiden, claiming or state bred allowance races not considered). The winning horse to receive free entry and start fees to the July 20 Molly Pitcher Stakes. The winning owner to receive a trophy. Closed Saturday, April 27, 2024 with 14 nominations.

KATHLEEN O. raced off the pace inside, then two wide, chased on the far turn, came four wide into the lane, rallied steadily outside and was going best late for the win. OCCULT raced three wide on the first turn, moved up to press the pace, bid two wide, dueled on the far turn, gained command nearing the quarter pole, led into the stretch, then drifted in in front of VENTI VALENTINE nearing the furlong marker bothering that rival, then drifted out at the sixteenth marker, dug in to the finish and yielded to the winner. VENTI VALENTINE raced three wide early, then set the pace on the inside, dueled on the far turn, dropped back a bit, was attempting to re rally, then was forced to check sharply when lacking room behind OCCULT nearing the eighth pole, rallied mildly inside after that. FROSTY O TOOLE stalked outside, three wide on the backside, chased three wide on the far turn, made a bid at the quarter pole, rallied mildly, was between rivals in the stretch run, steadied slightly at the sixteenth marker and outkicked TRVERSE away alertly in front of the field, then was rated back off the pace, tracked inside, chased inside on the far turn, raced evenly in the stretch and was steadied near the sixteenth marker. After the race, a Stewards' Inquiry was posted, along with rider's objections, VENTI VALENTINE and FROSTY O TOOLE against OCCULT, TRVERSE against the winner, OCCULT was disqualified and placed third.
