SAWASDEE took control early and showed the way up the backstretch, led along the rail through the turn, roused when confronted by THE CHOSEN VRON approaching the lane, lost command in upper stretch, was no match for the winner in the final furlong but was clearly second best. MOOSE MITCHELL tracked three wide into the turn, moved out to the four path around the bend and never produced a bid. CALIFORNIA TIGER tracked the speed outside MOOSE MITCHELL, navigated the turn four then five wide, moved inward in upper stretch and failed to menace. THERE WAS A WIN MINUS POOL OF\$3,838.12
