FIRST CALL set the pace along the inner rail, drifted out a bit entering the stretch, dueled inside the winner and just missed in a sharp effort. ARIZONA JEREMY, unhurried early, raced along the inner rail throughout, was well positioned entering the stretch and flattened out. MR LOVE MUFFIN, three wide both turns, chased the pace to the stretch and tired. MARICOPA COUNTY swung four wide leaving the far turn and lacked a rally. OUTOFQUEMADO chased the pace between horses down the backstretch and gave way on the far turn.
