FOREVER AFTER ALL tracked three wide, shifted to the four path into the turn, sustained gradual progress to close in on the clear leader in the final sixteenth, attempted a late bid but was kept atbay. HEAVENLY SUNDAY prompted inside of the pace setter before backing off to stalk around the first turn, pursued two wide down the backstretch, crept closer to press in the three path into the far turn, came under urging to sustain pressure turning for home, but failed to do so in upper stretch, chased into the final furlong, lost place to an outer rival at the sixteenth pole and held show. BE MY SUNSHINE settled off of the pace two wide, took the far turn in the three path before shifting to the five path entering upper stretch, then ran on willingly. PERSONAL BEST tracked along the inside, pursued from the two path around the far turn, but lacked a bid and faded. EMBRACE ME saved ground off of the pace and failed to factor. TOW ER BRIDGE trailed in the two to three path early on, then in the four path around the far turn and was outrun thereafter.
