6 FURLONGS. (1.06⁴) BUDWEISER S. Purse \$50,000 FOR THREE-YEAR-OLDS AND UPWARD. By Subscription of \$100 each, which shall accompany the nomination, by 2:00 PM Saturday, June 15, 2024 \$250 to enter, \$250 additional to start. A late Penalty Payment of \$750 may be made at time of entry. Purse to be divided as follows; 55% to the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% to be divided equally among the remaining finishers. Weights; Three Year Olds 121 lbs.; Four Year Olds and Older 125 lbs. Non-winners of \$22,000 in 2024 allowed 2 lbs.; Non-winners of \$15,000 in 2024 allowed 4 lbs. (Maiden, Claiming and Starter races not considered) Field size will be limited to 12 starters. In Allowance Stakes preference in the draw will be based on money earned. Starters to be named through the entry box by the closing time of entries. **NOMINATIONS CLOSED AT 2:00 PM SATURDAY, JUNE 15, 2024 WITH 11. THREE SUPPLEMENTAL NOMINATIONS.**

NEIMAN prompted PAPA'S GOLDEN BOY from along the outside, took the lead leaving the eighth pole and gradually drew clear. SLEW'S TIZ WHIZ was unhurried early, angled to the outside nearing the quarter pole, came six-wide into the stretch and finished full of run. PAPA'S GOLDEN BOY saved ground setting the pressured pace to the eighth pole, was unable to match strides with the winner late but held on well for the show. MONGOLIAN MEMORY saved ground while being allowed to settle, angled out to betwo-wide nearing the eighth pole and was gaining late. COASTAL KID was reserved off the early pace, came tree-wide into the stretch and improved his position during the drive. PRISONER was forwardly placed while racing four-wide on the turn but lacked a rally. COOL PAPA G moved up five-wide on the turn to be prominently place and weakened during the drive. COMPANY'S DREAM showed brief speed while racing three-wide and tired. PERFECT DUDE raced in the middle of the field on the turn while three-wide and gave way during the drive.
