BOTOX KATIE raced in the two path and bid belatedly behind the winner. EVIL INTENTIONS was bumped at the start and bid belatedly. BRITTANYSGLDNFAITH was off awkwardly. COMPRESSED ENERGY was squeezed back at the start and rallied belatedly outside to finish on even terms with BELLA FRANCES CA who raced evenly. TIZZY JOJO stalked the pace in the five path but faltered in the stretch. JURADICIAL vied between foes and faded in the stretch. BELLA BOLLE stalked the early pace in the four path and gave way.
