( 1401 ) **JIM AND SANDRA RASMUSSEN S.** Purse \$50,000 ( plus \$3,465 IBF – Iowa Bred Fund ) **FOR THREE-YEAR-OLDS & UPWARD.** Three-year-olds – 120 lbs.; Older – 126 lbs. Non-winners of \$60,000 at a mile or over in 2023–2024 allowed 2 lbs.; non-winners of \$45,000 at a mile or over in 2023–2024 allowed 4 lbs.; \$30,000 at a mile or over in 2023–2024 allowed 6 lbs. (Maiden and claiming races not considered) **No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START.** Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceed fourteen ( 14 ), high weights will be preferred. Then preference to start will be given to those horses having accumulated the highest lifetime earnings at the closing time of entries. Different owners will have equal draw according to weights. The second part of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees.

VELOCITOR was forwardly placed around the first turn and stalked two wide up the backstretch, advanced to engage MINE THAT STAR for the lead mid-way around the far turn, matched strides then took on the challenge of rail running AIN'T LIFE GRAND at the quarter pole, chased after a forementioned foe into upper stretch, dueled two wide for the lead into the final sixteenth, dug in gamely and edged away late. AIN'T LIFE GRAND was briefly restless in the gate then broke sharp and settled nicely while saving ground around the first turn, remained inside and stalked the pace up the backstretch, slipped through a narrow opening along the rail and challenged rivals for the lead at the quarter pole, cut the corner and shook free at the head of the lane, took on the challenge from VELOCITOR mid-stretch, fought back gamely then failed to move on late. MINE THAT STAR led the way around the first turn and set the pace up the backstretch, took on the challenge of VELOCITOR mid-way around the far turn, vied past the quarter pole then failed to move on with the top pair and kept on for a share. HAYES STRIKE raced in range three wide up the backstretch, edged closer, raced in aim three to four wide at the quarter pole, flattened turning for home and just missed show. DOUBLE CROWN raced off the early pace, swung four to five wide into upper stretch and failed to rally. ALEJANDRO was not too far back being rated just off the early pace, given cue along the outside entering the final turn, failed to move on past the five sixteenths pole and gave way. KEEN HEIR raced in the back, lost contact with the field around the far turn and was distanced.
