CIRCLE OF TRUST settled off the pace a bit off the rail, drew closer under aride on the far turn, angled four wide into the stretch, took over outside theeighth pole, kicked clear approaching deep stretch and held safely. SAKURA BLOSSOM took a bump from inside leaving the gate, trav eled at the back on the inside, trailed two wide into the far turn, swung out into the lane, finished well to gain the place but could not reach the winner. FAITH UNDERSTOOD unhurr ied in the early going and moved inside, lacked room on the far turn and trailed a bit off the rail into the lane, went between rivals in upper stretch but ran into traffic br iefly at the eight pole, tipped out int o the clear, then had to steady when losing her path near the sixtee nth pole and kept on to gain third. PINK WHITNEY broke out and bumped rival, raced two wide near the back, moved up three deep, bid three wide into the lane, fought to midstretch and flattened in the last sixtee nth. VISUALLY rated in the two path then stal ked on the inside thr ough the far turn, cut the corner into the lane, asked right handed at the top of the stretch and weakened. SEA DAN CER stepped to the front and moved inside, showed the way up the backstretch and far turn, challenged from outside leaving the bend, relinquished the lead in upper stretch and weakened in the furlong grounds. SHILOH'S MISTRESS bobbled leav ing the gate, forwardly placed while racing keenly first time through the stretch, stalked three wide outside a rival around the first turn, ridden alongtwo wide on the second bend, got put in tight betweenthe leaders and was forced to check at the top of the stretch, then faded past the eighth pole.
