CHISMOSA lacked early speed racing inside a rival, went two wide into the turn, made progress under a ride on the turn, asked left handed and angled four wide past the quarter pole, closed in and took aim at the top pair entering the final furlong, headed the runner-up at the sixteenth pole and drove clear. RICHI (CHI) prompted the pace from outside then vied three deep past the half-mile pole, dueled outside TOM'S REGRET around the bend, battled with that rival to midstretch, confronted by CHISMOSA on the outside with a sixteenth remaining, yielded to that rival and kept on to secure second. TOM'S REGRET set the pace early while under pressure then dueled past the half-mile pole, fought inside RICHI (CHI) through the turn, lost command in upper stretch and stayed on well from the fence for the show honors. ANYWHO chased the top pair for a bit then went up to press between rivals at the half-mile pole, could not keep up with the leaders early on the turn and gave chase again two to three wide, churned on down the lane and earned a minor award. OUT SIDE THE LAW stalked the behind the leaders on the inside, lost ground and chased out of range a bit off the rail into the stretch, then weake ned in the furlong grounds. DELITEF ULL HART raced outside the winner at the back early, trailed three then two wide around the bend and was never a factor.
