IMPLICATED settled off the pace about mid-pack racing in the two path into the turn, moved out four wide in upper stretch seeking room, took aim on the leader and soon obtained the lead in the vicinity of the furlong marker, drew clear under moderate urging. FEV ROVER (IRE) was forced out and appeared to lightly brush with a foe at the start, settled off the pace, was outside foes on the turn racing three to four wide, swung out seven deep for the drive, closed mildly but was only second best. MILLIE GIRL settled at the back, raced inside a foe but off the rail on the turn, fanned eight wide turning for home, kept on well while widest but couldn't quite get the place. FULL COUNT FELICIA broke outwardly, moved forward between foes two to three wide to contest the pace, took over a narrow lead racing off the rail then moved clear by the seven-sixteenths, had no extra for the lane. FOREVER DIXIE settled at the back racing off the inside, was mostly two to three wide, gained mildly late. SAFEEN moved through inside to briefly vie for the early lead, dropped back slightly at the five- and one-half, continued close up in behind while being guided out three wide coming to the top of the stretch, lacked the needed late kick and weakened in the final furlong. FAST AS FLIGHT got away alertly and had the early lead while racing very wide, shifted in to regain contact with the others in pursuit four to five wide headed to the turn, weakened in the stretch. DEVIL'S BIT angled in after the start, settled off the pace inside saving ground through the turn, failed to menace. DANA'S BEAUTY was lightly brushed at the start, had good early position stalking three to four wide, weakened in the stretch. CAIRO CONSORT settled outside the back, fanned seven wide turning for home, failed to menace.
