ISCREAMUSCREAM showed good early speed to take the front and moved inside, headed by OMAHA GIRL in the middle stages, held a short lead over a trio of rivals leaving the far turn, put away OMAHA GIRL in upper stretch, fought with ZONA VERDE (IRE) through the final furlong and held gamely. ZONA VERDE (IRE) settled in the two path, chased three deep leaving the backstretch, rallied four wide around the far turn, battled outside ISCREAMUSCREAM through the furlong grounds and could not summon the needed late kick to get by. MEDORO broke a step slow, laid off the pace three then two wide on the clubhouse turn, was on the move between rivals approaching the far turn, got knocked into inner rival early on the bend then had to wait when boxed in, angled out into the clear near the stretch, closed well in the lane and earn the show honors. SAKURA BLOSSOM reserved in the early going and taken inside, got bumped early on the far turn, tipped out and went between rivals, chased two wide into the drive, lacked a clear path and altered course at the eighth pole, then kept on for a minor award. OMAHA GIRL raced up close to the outside of the early leader, drew alongside and headed the pacesetter in the middle stages, battled two wide around the far turn, yielded to the winner in upper stretch and weakened. LOTERIE (IRE) tracked in hand on the inside, moved off the rail and drew closer into the far turn, bid three deep at the five-sixteenths pole, got crowded a bit at the top of the lane and weakened. INVINCIBLE MOLLY (GB) bobbled leaving the gate, unhurried and traveled in the two path in the opening stages, came under a ride while angling out to the five path on the far turn and could not rally in the stretch. SEA DANCER brushed the gate, taken back shortly after the start then raced keenly early on the inside, ran into traffic at the five-sixteenths pole then angled out, moved back inward in the lane and was not a factor. RASCALITY fractious in the gate, well placed along the inside, look to challenge the top pair from the rail but got put in tight and steadied at the five-sixteenths pole, continued along the fence to the stretch and weakened. FLATTERY stalked two wide early, shifted in and bumped past the three-eighths pole, dropped back and trailed in the three path into the stretch and tired.
