**7 FURLONGS. ( 1.20 ) AZALEA S. Purse \$95,000 ( includes \$20,000 FTBOA – FL TB Owner Brdr Assoc Fund ) FILLIES, THREE YEARS OLD. Free nomination by Sunday, June 30. \$750 to enter. A \$100 supplemental nomination fee may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 12% to third, 5% to fourth, and 3% to fifth. \*(FTBOA offers \$20,000 to the owners of a registered Florida-bred divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 123 lbs. Non-winners of a graded stakes race allowed 3 lbs.; a stakes race or two races other than maiden, claiming, starter or restricted allowance, 5 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, stakes placed then by highest career earnings.**

HAULIN ICE rated in the five path, ranged up three wide under rousing midway around the turn, took command while floating out to the five path at the top of the lane, and kicked away. MIUCCIA bumped with an outer foe at the start, tracked in the two path, was coaxed along the rail around the turn, angled out passing the quarter, chased on from the five path down the stretch for place. CANDY GRAY bumped with an inner foe at the start, trailed in the four path, was driven around the turn, and was along in the seven path down the lane for show. STILETTO HEELS pressed the pace in the three path but yielded at the top of the stretch. R HARPER ROSE set the pace in the two path, was cued from off the rail passing the three-eighths pole, but gave away in the stretch. MARSHMALLOW QUEEN stumbled at the start, chased inside but never menaced. FIELDS OF GREEN broke out at the start, stalked in the four path but was empty entering the lane.
