JAIL HOUSE JUSTICE was bumped at the start, was unrushed inside, angled four wide at the quarter pole, rallied but couldn't get to the winner. MOLLY'S TOWN pressed the early pace in the three path, bid at the half-mile pole, was clear and was caught. KINGS BURY ROAD stalked the pace in the four path, bid at the eighth pole but couldn't close late. CLASSIC EXPRESS hopped at the start, and rallied belatedly inside. BLACK WHITE N GOLD stalked the pace inside, then yielded in the stretch. POSITIVE CHANGE found his best stride late inside. NEUTRON led early in the two path, angled to the three path at the half-mile pole. MOPED MO was unrushed, bid in the five path at the three-eighths pole but faltered. TAKEITANDRUN raced five wide, bid at the five-eighths pole, pressed the pace and gave way at the quarter pole.
