1 MILE 70 YARDS. (1.39¹) MICHAEL G. SCHAEFER MEMORIAL S. Purse \$100,000 FOR THREE YEAR OLDS AND OLDER. No nomination fee. \$100 to pass the entry box and an additional \$150 to start with \$100,000 Added. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$625, which includes entry and starting fees. After payment of 1% to all owners of horses finishing sixth through last the remainder of the purse will be divided; 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights; Three Year Olds, 122 lbs. Older, 125 lbs. Non-winners of \$60,000 at a mile or over in 2024 allowed 2 lbs.; of \$30,000 twice at a mile or over in 2024 allowed 4 lbs.; of \$25,000 twice at a mile or over allowed 6 lbs. Maiden, claiming, starters and state bred races will not be considered when estimating allowances. Closed on Friday, June 21, 2024, with 44 Nominations.
