FOREVER SOUPER assumed the early lead, set the pace slightly off the rail and readily drew out through the stretch while under urging. HIGHLAND CHIEF (IRE), a forward factor outside the winner, chased him to mid way on the far turn, raced three deep leaving the turn, bumped with HARDSPUN REASON at the head of the lane and weakened. THE ADDISON POUR, steered inward approaching the first turn, hugged the inner rail on the far turn, bumped with HARDSPUN REASON at the head of the stretch and weakened. HARDSPUN REASON, unhurried early, a dvanced in narrow quarters between horses leaving the far turn and was jostled on both sides at the top of the lane. Objections by the riders of THE ADDIS ON POUR and HARDSPUN REASON against HIGHLAND CHIEF for alleged interference near the quarter pole were not allowed. There was a stewards' inquiry concerning the run into the stretch but no action was taken.
