**1 1/8 MILES. ( Turf ) ( 1.454 ) PRINCE GEORGE'S COUNTY S.** Purse \$100,000 **FOR THREE YEAR OLDS AND UPWARD.** Which have not been permitted Lasix within 48 hours of Post Time. By free nomination. \$500 to pass the entry box, \$500 additional to start, with \$100,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Weight: Three-Year-Olds, 120 lbs.; Older, 126 lbs. Non-winners of \$60,000 twice at a mile or over in 2024 allowed 2 lbs.; one such race in 2024, 4 lbs.; of \$40,000 once at a mile or over in 2024, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). Trophy to the owner of the winner. Closed Sunday, June 30, 2024 with 27 nominations. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the maintrack at One Mile and One Eighth) (Rail at 35 feet).

FOREVER SOUPER assumed the early lead, set the pace slightly off the rail and readily drew out through the stretch while under urging. HIGHLAND CHIEF (IRE), a forward factor outside the winner, chased him to mid way on the far turn, raced three deep leaving the turn, bumped with HARDSPUN REASON at the head of the lane and weakened. THE ADDISON POUR, steered inward approaching the first turn, hugged the inner rail on the far turn, bumped with HARDSPUN REASON at the head of the stretch and weakened. HARDSPUN REASON, unhurried early, advanced in narrow quarters between horses leaving the far turn and was jostled on both sides at the top of the lane. Objections by the riders of THE ADDISON POUR and HARDSPUN REASON against HIGHLAND CHIEF for alleged interference near the quarter pole were not allowed. There was a stewards' inquiry concerning the run into the stretch but no action was taken.
