6 FURLONGS. (1.071) SAYLORVILLE S. Purse \$100,000 FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Three-Year-Olds - 122 lbs.; Older - 126 lbs. Non-winners of \$60,000 since October 1st, 2023 allowed 2 lbs.; non-winners of \$45,000 October 1st, 2023 allowed 4 lbs.; \$30,000 since October 1st, 2023 allowed 6lbs. (Maiden and claiming races not considered) No nomination fee. \$500 to pass the entry box and \$1,000 additional to start. ENTRY AND START FEES WILL BE WAIVED FOR ANY HORSE THAT HAS WON A GRADED STAKE IN 2024. \$100,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$2,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then highest 2023-2024 earnings. Different owners will have equal draw according to weights. Failure to draw into the race cancels all fees.

UN Sung MELODY tracked the pace along the inside up the backstretch, continued unleashed inside around the turn, given cue turning for home, slipped through along the rail at the head of the lane, took control over the lead, widened advantage and kept to task. HAPPY AM I rated two to three wide just off the top trio in the opening quarter, loomed closer three wide late on the turn, hustled along four then three wide into upper stretch, sustained response through the lane and finished second best. FAITH ALONE was allowed to settle out of the gate and raced in the back in the opening quarter, launched a two wide bid late on the turn, shifted out to race five paths wide at the top of the lane, sustained a steady bid and gained a share. DEALING JUSTICE rated off the early pace, saved ground around the turn, tipped out four wide for the drive and had a mild improve. PALACEIN sped to the lead at the start, set the pace near the inside up the backstretch, continued on top around the turn, came two wide into upper stretch, got collared for the lead and gave way. OLGA ISABEL was forwardly placed up the backstretch, raced in striking distance at the quarter pole, went to go three paths wide into upper stretch, got in tight quarters, steadied and gave way. THE STEWARDS POSTED AN INQUIRY AND THE JOCKEY OF OLGA ISABEL CLAIMED FOUL AGAINST HAPPY AM I FOR INTERFERENCE AT THE HEAD OF THE LANE, AFTER REVIEW NO ACTION WAS TAKEN
