Lasix not allowed within 48 hours of post time pursuant to HISA Rule 4212. By subscription of \$135 each which should accompany the nomination; \$675 to pass the entry box and an additional \$675 to start. For horses not originally nominated, a supplemental payment of \$675 in addition to the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 55% to the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight 124 lbs. Non-winners of two races other than maiden, claiming, starter, state-bred allowance in 2024 or a State-bred stake lifetime allowed 2 lbs.; of two races other than maiden, claiming, starter or state-bred allowance lifetime or a race other than maiden, claiming, starter or state-bred allowance in 2024 allowed 4 lbs. A presentation will be made to the winning owner. Closed Saturday, June 29, 2024 with 17 Original Nominations and 1 Supplement.**

MISS JUSTIFY chased along the inside and then just off the inside into the far turn, came under coaxing near the quarter pole and took the inside route into upper stretch, rallied up the rail to issue a challenge through the final furlong, seized command seventy yards from the finish and prevailed safe on the wire. STRIKER HAS DIAL coaxed from the gate, led briefly early on before DAZZLING MOVE did so and swept to the front seven furlongs from home, chased that rival three then two wide advancing into the far turn, assumed command nearing the five-sixteenths, swung three wide into upper stretch, dug in under a drive drifting slightly out until corrected and angled in just inside the eighth pole to look the aforementioned foe in the eye, got collared with seventy yards to the finish and dug in loosely between foes late to preserve the place honors. COURBE stumbled at the start, raced just off the inside through the opening dog legged turn, then chased three to four wide coming under coaxing at the five-sixteenths, angled five wide into upper stretch, shied in under a right handed crop a furlong out and offered up a mild kick. LADY MOSCATO bobbed at the break, chased two to three wide coming under coaxing at the five-sixteenths, swung four wide into upper stretch, weakened. BELLS BEACH broke out at the start, chased four wide through the first turn and then four to five wide thereafter, came under coaxing at the seven-sixteenths, went seven wide into upper stretch and made no impact. WINDY WALK lost her rear footing at the start, raced three wide through the first turn before chasing six then five wide down the backstretch, tucked four then three wide through the far turn and continued three wide into upper stretch and was unable to make an impact. DAZZLING MOVE broke out at the start and was corrected and then came with a rush five then four wide through the first turn to take command seven furlongs from home, spurted away tucked to the two path down the backstretch, then tucked inside into the far turn coming under growing threat to the outside, yielded the front readily inside the three-eighths marker and faded, went just off the inside into upper stretch and was eased home through to the finish.
