1/8 MILES. (148³) CENTURY CASINO OAKS Purse \$100,000 (includes \$100 Starters Bonus) A BLACK TYPE STAKE FOR THREE-YEAR-OLD FILLIES. A fee of \$100.00 required to nominate. A payment of \$1000.00 is required to pass the entry box and an additional \$900.00 is required to start. The purse will be divided \$60,000 to the owner of the winner, \$20,000 to the second place finisher, \$10,000 to the third place finisher, \$5,000 to the fourth place finisher and \$2,000 to the fifth place finisher. A payment of \$500 will be paid to all horses who start and finish 6th or worse. Starters to be named through the entry box by the closing time of entries. Preference will be determined by stakes earnings in 2024 then by stakes earnings lifetime, then by earnings in 2024, then by lifetime earnings at time of entry. The field will be limited to 12 starters with 2 horses placed on the also-eligible list. The status of also-eligible horses will be determined at 10:00 AM MST on Saturday August 24th, after pre-race veterinarian examinations. A trophy will be presented to the winning owner. Weight : 124 lbs.

AVANA stumbled leaving then was allowed to settle, targeted the leaders then blazed by them at the head of the lane and wrapped up with enthusiasm. MIDNIGHT LADY stalked inside under a hold, prompted the pace, was roused at that the quarter pole but was no match for the winner and held safely. SILKSTONE led the way into the backstretch, dueled outside of MIDNIGHT LADY, and weakened in the final sixteenth. WHO'S THAT BABY stalked four wide, rallied four wide leaving the final turn, and improved late. BROOKE MAGIC reserved off the early pacesetters, waited near the five-sixteenth pole, lacked running room early stretch, and gave way. KULSUM offered little. ANNAMARIA was in tight then clipped heels in the opening turn, and tired early. STEWARDS INQUIRY- The Stewards conducted an inquiry into the first turn involving ANNAMARIA but made no change.
