5½ FURLONGS. (1.014) GRADUATION S. Purse \$100,000 (includes \$1,500 CBOIF – California Bred Owner Fund) FOR GOLDEN STATE SERIES ELIGIBLE CALIFORNIA BRED OR CALIFORNIA SIRE TWO-YEAR-OLDS. By subscription of \$100 each, which shall accompany the nomination, Closed Thursday August 1, 2024 with 13 or by supplementary nomination of \$1,000 each. (non-Golden State Series eligible horses, \$25,000 to supplement — which will make that horse eligible to all future Golden State Series Stakes) by closing time of entries. All horses to pay \$1,500 additional to start, with \$100,000 Guaranteed, of which \$57,000 to first, \$19,000 to second, \$12,000 to third, \$6,000 to fourth, \$4,000 to fifth and \$2,000 to sixth. Weight 122 lbs.; Non-winners of two races other than claiming allowed 2 lbs.; of a race other than claiming, 4 lbs. High weights preferred. Total earnings in non-claiming races will be used in determining the preference of horses with equal weights. A trophy will be presented to the winning owner.

R HEISMAN bumped leaving the gate, chased between foes then had to steady off heels early, waited for room behind the leader past the five-sixteenths pole, roused leaving the bend, chased within striking distance into deep stretch, then came with a late bid and drove past the runner-up in the final strides. CASE HIT brushed inner rival at the start, took control early under pressure from I'M A BAD BOY to the outside, shook free at the quarter pole, led clear into deep stretch and got run down by the winner approaching the wire. I'M A BAD BOY pressed the pace between rivals up the backstretch, asked to keep up around the bend, lost contact with the leader at the quarter pole, came three wide into the lane, weakened but managed to secure the show. THE GYPSY COWBOY coaxed from the gate, climbed a bit and dropped back, raced off the rail into the turn, angled out around the bend and spun seven wide into the lane, kept trying in the drive and earned a minor award. LAST CALL ZONDLO broke out, attended the pace outside the top pair, chased the leaders three then four wide past the quarter pole and faded down the lane. BODACIOUS got bumped on both sides and put in tight early, moved up between rivals but had to steady off heels at the half-mile pole, ridden a long three, four, then five wide on the turn and flattened out. TIMTY got brushed from outside then bumped with inner rival shortly after the start, chased wide into the turn, navigated the bend five then six wide and had little left for the stretch run. NAP stalked from inside, lost ground around the turn, entered the lane in the two path and weakened. INFAMOUS ANGEL tracked four deep leaving the backstretch, moved into the three path on the turn, came four wide into the stretch and failed to menace.
