7 FURLONGS. (1.20²) AUDUBON OAKS Purse \$175,000 (includes \$75,000 KTDF – Kentucky TB Devt Fund) **FOR FILLIES THREE-YEAR-OLDS** . Free nomination, \$500 to pass the entry box and \$500 additional to start. Supplementary nominations may be made at time of entry by payment of \$1,500 (includes entry and starting fees). \$100,000 Guaranteed plus an additional \$75,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth Weight: 122lbs. Non Winners of a graded sweepstakes in 2024 allowed 2, lbs. a sweepstakes since March 12, 4 lbs. Starters to be named through the entry box by the usual time of closing. The maximum number of starters for the **AUDUBON OAKS** will be limited to fourteen (14) starters. Preference to start will be given to graded stakes winners (in order I–II–III) then those horses having accumulated the highest lifetime earnings. A trophy will be presented to the winning owner. Nominations closed Saturday, July 27, with 28 nominations.

FIBBER stalked the early trio, raced in the four path into the lane, made a bid down the lane, drove past the leader near the sixteenth pole and cleared in the final stages. TARIFA vied early on from the inside, raced in the two path into the lane, was under a long drive down the lane but was no match for the winner in the late stages. ADOGATE trailed the field early on, raced in the three path into the lane and moved up late in the stretch run. MINK'S PALACE vied for the lead early on from between horses, was in the three path into the lane, under a long drive in the upper stretch but faltered down the lane. TAMBO was a bit slow at the start then was rushed up and vied three wide early on, raced in the four path into the lane and gave way.
