MINE THAT STAR tracked inside, was roused passing the threeeighths pole, and kept on from the two path down the lane for show. NUMBER ONE DUDE stalked in the four path, floated out to the seven path turning into the stretch, and flattened. FORCED RANKING chased in the four path but never menaced. PAL UXY trailed throughout.
