TURNERLOOSE rated nicely off of the early pace, tracked from the second flightentering the clubhouse turn, well placed through the backstretch run, chased two to three wide into the far turn, given her cue into upper stretch, made a quick move to assume command and kicked clear at the furlong marker, drifted out past mid-stretch, kept to task approaching the sixteenth-pole and drew away under hand urging in the late stages. DELUSIVELY allowed to settle, raced two wide into the first turn then shifted to the inside entering the backstretch run, unhurried heading to the half-mile marker, saved ground into the farturn, angled three wide for the drive and rallied at mid-stretch, could not keep pace with the winner into the final sixteenth and outfinished LAK OTA SPIRIT for the place honors. LAKOTA SPIRIT unhurried away from the start, saved ground into the first turn, shifted to the two path into the backstretch run, gained ground into the far turn, roused four wide into the stretch and rallied at the furlong marker, could not match strides with the winner into the final sixteenth, outfinished for second and clear in the end for third. GRACE PERIOD (FR) prominent away from the start, engaged with LEISUREWEAR in the early stages and prompted that rival through moderate fractions into the backstretch run, kept close attendance while outside of LEISUREWEAR heading to the half-mile marker, pressed the pace into the far turn, could not match strides with on coming rivals into the stretch and faded in the late stages. LEISUREWEAR (IRE) bobbled a bit at the start, recovered and assumed early command, showed the way into the first turn, set moderate fractions while prompted into the backstretch run, dueled GRACE PERIOD into the far turn, lost the lead into upper stretch and gave way in the final furlong. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate time.
