JONATHAN'S WAY set the pace inside of a prompting rival into the turn, held a margin as a wider rival took up chase turning for home, repelled that foe entering the lane, kicked away in upper stretch and held sway. OWEN ALMIGHTY tracked two to three wide and between horses, drifted out to the five path while staying on in upper stretch, rallied to reach place leaving the furlong grounds and narrowed the winner's margin in the late stages. GIOCOSO tugged forward to track three wide and between horses, continued progress to attempt a bid outside of the leader leaving the three furlong pole, sustained pressure nearing the lane, but was turned away at the quarter pole, failed to keep pace in upper stretch, lost place at the furlong grounds and held show thereafter. MESERO laid off of the pace in the two path, tipped to the three path entering the lane, then advanced between horses through midstretch and stayed on willingly. SANDMAN broke a step slow and brushed with an outer foe at the start, lacked speed in the two to three path and moved up between horses. JACK'S TIME stalked along the inside, chased into the lane and gave way. MAGNITUDE brushed with an inner foe upon leaving the gate, pressed outside of the eventual winner, then weakened between horses reaching the five sixteenths pole. STRUMMIN lagged behind early on, took the turn in the three path, swung out to the eight path entering the lane and improved position. AUTHENTIC STRIKE tracked forwardly four wide, but faded in the five to six path leaving upper stretch. FIRMUS retreated down the backstretch, raced far back in the five to four path around the turn and got outrun. POLITICALLYCORRECT broke a step slow and was last away, lacked speed in the five path and made little impact.
