By subscription of \$125 each, which shall accompany the nomination, Closed Thursday August 22,2024 with 14 or by supplementary nomination of \$1,250 each by closing time of entries, \$1,875 additional to start, with \$125,000 Guaranteed, of which \$75,000 to first, \$25,000 to second, \$15,000 to third, \$7,500 to fourth and \$2,500 to fifth. Weight 124 lbs.; Non-winners of \$60,000 at one mile or over allowed 2 lbs.; of such a race of \$40,000 in 2024, 4 lbs.; of such a race anytime or \$30,000 any distance since March 1, 6 lbs.; (Maiden and claiming races not considered.) MUTH away quickly, took a stalking position from inside then tipped two wide on the clubhouse turn, pressed the leader briefly then stalked up the backstretch, bid two wide around the far turn, took over approaching the quarter pole, fought inside IMAGINATION into the lane, put that rival away inside the eight pole and remained clear under steady handling in deep stretch. INDISPENSABLE reserved in the two path, moved over to the inside crowding MC VAY on the first turn then moved back to the two path around the bend, ridden along two then three wide on the far turn and rallied for second. IMAGINATION tracked five wide into the first turn then angled over to the three path, moved up three deep in the middle stages, bid three deep on the far turn, fought outside MUTH into the stretch, could not sustain the challenge with a furlong remaining and flattened to third. MC VAY unhurried along the rival then got put in tight by INDISPENSABLE into the first turn, climbed at the back around the bend, passed WYNSTOCK up the backstretch, navigated the far turn three then four wide and kept on for a minor award. PONY EXPRESS led in the two into the clubhouse turn then found the rail around the bend, pressured early on the backstretch before clearing a gain at the five-eighths pole, pressured again with three furlongs remaining, roused at the five-sixteenths pole, lost command approaching the quarter pole, chased the top pair into the lane and gave way. WYNSTOCK sat off the pace off the rail or outside a rival, trailed at the midway point, went two wide into the far turn, came five wide into the stretch and was never involved. DE' MEDICI stalked four then three wide on the first turn then altered in late on the bend, traveled along the rail then two wide into the stretch and had little left for the drive.
