SOUL OF AN ANGEL had a slow start and trailed in the three path, was coaxed along from the two path around the turn, angled out to the seven path tuning into the lane, got herded out by an inner foe while rallying into the final furlong, but drew clear of that foe in the final sixteenth to win. BETH'S DREAM laid up close in the four path, bid passing the three-eighths pole, took command under coaxing passing the quarter, floated out to the five path entering the lane, opened up but was drifting out on her left lead passing the eighth pole, and yielded to an outer foe in the final sixteenth to place. BATTLE CRY raced in midpack from the three path, was ridden between foes around the turn, floated out to the seven path in upper stretch, and finished evenly for show. IMONRA tracked in the two path, was driven from the rail around the turn, swung out to the four path turning into the stretch, but flattened. MARYQUITE CONTRARY raced off the pace in the three path but made no impact from the center down the lane. UNSOLVED MYSTERY chased in the five path but faded in the stretch. COUSIN KRISTI set the pace in the two path but weakened from the three path down the lane. GALLOP D'HERMES rated in the five path but failed to threaten on her left lead in the stretch. PACHOLLI (URU) prompted the pace in the four path but was done early.
