JOHANNES tracked from inside, gained through the far turn, tipped two wide leaving the bend and challenged CONCLUDE from outside at the three-sixteenths pole, bumped with that rival shortly after while putting a head in front, then drove clear in the final sixteenth. ALMENDARES (GB) reserved two to three wide early, traveled outside a rival at the back, steered out in upper stretch and rallied to get up for second. CONCLUDE stepped to the front and crossed over to the inside, showed the way clear along the inside to the stretch, came off the rail and bumped with JOHANNES in upper stretch while losing command, fought to the sixteenth pole, yielded late and lost second at the wire. TRIKARI settled outside a rival, chased between rivals at the quarter pole. moved out in the lane, finished willingly and missed third. EASTER (FR) off slow in the beginning, coaxed along early trailing the field and moved inside, came under a ride on the far turn, hugged the rail to the stretch, and produced a mildrally. DU JOUR broke a step slow, settled inside off the pace, ridden along while continuing to save ground around the far turn, moved to within striking distance on the fence but could not summon the nee ded late kick. ASTRON OMER moved inside quickly then shifted to the two path stalking the pacesetter, chased two wide on the far turn then three wide leaving the bend and weakened in the final furlong PACKS A WAHLOP steadied briefly when ASTRONOMER crossed in front early, stalked two then three wide around the clubhouse turn, chased three deep at the quarter pole, tipped out while the rider lost his left rein briefly into the stretch and weakened down the Iane. FOLLOWING AN INQUIRY INVOLVING THE INCIDENT BETWEEN JOHANNES AND CONCLUDE IN UPPER STRETCH. THE STEWARDS RULED THAT THE CONTACT WAS MUTUEL AND THERE WOULD BE NO CHANGE.
