For horses not originally nominated, a supplemental nomination payment of \$1,000 in addition to the entry and starting fees may be made at any time prior to the closing of entries. SENBEI hustled from the gate, chased three then two wide coming under coaxing at the five-sixteenths, angled six wide into upper stretch, rallied outside the top trio and was herded out three paths from the eighth pole to near the sixteenth marker due to pressure from the drifting leader DETERMINED KINGDOM, seized command seventy yards from the finish and edged away to prevail in the late stages. NOTHING BETTER coaxed from the start, showed the way early on from the two path before being engaged by DETERMINED KINGDOM head to head with nine-sixteenths remaining, duelled through the turn coming under coaxing near the quarter pole, swung four wide into upper stretch, continued to knock heads through the stretch and had his main pac rival come out under a left handed crop and was herded out four paths from the eighth pole to the sixteenth marker when taking narrow and brief command at that station, got collared with seventy yards to the finish and ran on to preserve the place honors on the wire. ALOGON three wide in pursuit, came under coaxing near the quarter pole, swung five wide into upper stretch, dug in under a drive and was herded out three paths from inside the eighth pole to near the sixteenth marker while running on to secure the show honors. SON OF A BIRCH broke in a step at the start, chased three wide coming under coaxing at the five-sixteenths, angled three to four wide into upper stretch, angled in and was then carried in lightly by MISCHIEVOUS ANGEL near the eighth pole, skimmed the rail and rallied to kick on belatedly to the finish. DETERMINED KINGDOM broke out at the start and was corrected, advanced to duel inside of NOTHING BETTER from the nine-sixteenths, knocked heads through the turn and was set down spinning two to three wide into upper stretch, dug in under threat and came under a left handed crop and drifted out from the eighth pole to near the sixteenth marker herding out NOTHING BETTER a total of four to five paths and also ALOGON and SENBEI three paths, got headed a sixteenth out, then weakened in the late stages. MISCHIEVOUS ANGEL broke out at the start bumping MAYA PRINCE, chased just off the inside and then along the inside under coaxing from the three-eighths, swung three to four wide into upper stretch, angled in near the eighth pole briefly carrying in SON OF A BIRCH, then weakened in the late going. AXTHELM coaxed from the gate, chased along the inside coming under coaxing half a mile from home, spun just off the inside into upper stretch and offered no response. MAYA PRINCE got bumped at the start by MISCHIEVOUS ANGEL, chased just off the inside under a ride from three furlongs out, went four wide at the top of the stretch and trailed throughout.

SENBEI hustled from the gate, chased three then two wide coming under coaxing at the five-sixteenths, angled six wide into upper stretch, rallied outside the top trio and was herded out three paths from the eighth pole to near the sixteenth marker due to pressure from the drifting leader DETERMINED KINGDOM, seized command seventy yards from the finish and edged away to prevail in the late stages. NOTHING BETTER coaxed from the start, showed the way early on from the two path before being engaged by DETERMINED KINGDOM head to head with nine-sixteenths remaining, dueling through the turn coming under coaxing near the quarter pole, swung four wide into upper stretch, continued to knock heads through the stretch and had his main pace rival come out under a left handed crop and was herded out four paths from the eighth pole to the sixteenth marker when taking narrow and brief command at that station, got collared with seventy yards to the finish and ran on to preserve the place honors on the wire. ALOGON three wide in pursuit, came under coaxing near the quarter pole, swung five wide into upper stretch, dug in under a drive and was herded out three paths from inside the eighth pole to near the sixteenth marker while running on to secure the show honors. SON OF A BIRCH broke in a step at the start, chased three wide coming under coaxing at the five-sixteenths, angled three to four wide into upper stretch, angled in and was then carried lightly by MISCHIEVOUS ANGEL near the eighth pole, skimmed the rail and rallied to kick on belatedly to the finish. DETERMINED KINGDOM broke out at the start and was corrected, advanced to duel inside of NOTHING BETTER from the nine-sixteenths, knocked heads through the turn and was set down spinning two to three wide into upper stretch, dug in under threat and came under a left handed crop and drifted out from the eighth pole to near the sixteenth marker herding out NOTHING BETTER a total of four to five paths and also ALOGON and SENBEI three paths, got headed a sixteenth out, then weakened in the late stages. MISCHIEVOUS ANGEL broke out at the start bumping MAYA PRINCE, chased just off the inside and then along the inside under coaxing from the three-eighths, swung three to four wide into upper stretch, angled in near the eighth pole briefly carrying in SON OF A BIRCH, then weakened in the late going. AXTHELM coaxed from the gate, chased along the inside coming under coaxing half a mile from home, spun just off the inside into upper stretch and offered no response. MAYA PRINCE got bumped at the start by MISCHIEVOUS ANGEL, chased just off the inside under a ride from three furlongs out, went four wide at the top of the stretch and trailed throughout.
