By subscription of \$200 to accompany the nomination by Midnight Saturday, September 28, 2024 with an additional \$1,500 to enter and \$2,000 to start. \$100,000 guaranteed of which 55% goes to the winner, 20% to second, 10% to third, 5% to fourth and 4% to fifth, and 2% to sixth through eighth, finishers ninth through twelfth will receive their starter fee back. High Weights preferred. Total earnings as recorded by Equibase in 2023-2024 will be used in determining preference of horses assigned equal weights. Starters to be named through the entry box by closing time of entries. Field limited to 12 starters.

APPREHEND stalked the pacesetter into the backstretch the first time while racing one out from the rail, maintained his position through the third turn and in the run down the backside the final time, launched his bid three wide entering the final turn, and closed willingly three wide in the drive to prove best. SUNBIRD tracked the pacesetter into the backstretch the first time while racing one out from the rail, held his position through the third turn and in the run down the backside the final time, rallied two wide from between rivals entering the final turn, held a narrow advantage into the lane, but was unable to fend off a determined APPREHEND late while proving clearly second best. SETTECENTO raced to the lead from along the rail entering the backstretch the first time, continued to dictate the pace through the stretch the second time, controlled the pace in the run down the backside and into the final turn, was overtaken soon after entering the final turn, and finished from along the rail in the drive to hold on for a share. AT ATTENTION stalked the leader into the backstretch while saving ground at the rail, held his position while under snug restraint through the stretch the second time, continued down the backstretch the final time while hemmed in at the rail, trailed the field into the final turn, while commencing a two wide bid, and finished one out from the rail in the drive to just miss the show spot. SOARINGFORTHE SUN hopped slightly at the start, and trailed the field into the backstretch the first time, continued to bid his time three wide through the stretch the second time and in the run down the backside the final time, rallied smartly four wide entering the final turn to loom a threat, but weakened late while unable to sustain his bid.
