DATTTS LIFE was jostled at the start, raced well back, rallied in the five path at the three-eighths pole, gained the place but was no match for the winner. THEO'S PROMISE stalked the pace in the four path and gained the show spot late. POSITIVE CHANGE stalked the pace between rivals, went to the rail in the stretch and gave way. ROCKETING saved ground, bid in the three path at the quarter pole but couldn't close late. CAPTAIN'S BEST bore in at the start, raced in the five path, bid four wide at the three-eighths pole and faltered. TREMOR led in the five path early, bid at the three-eighths pole, drew off, was caughtat the quarter pole and gave way. INSTINCTUALLY stalked the pace in the three path and gave way near the three-eighths pole. CRINGE was jostled at the start and was through early. AN DELE ANDELE saved ground and gave way in the stretch.
