No nomination fee, \$150 to pass the entry box, and an additional \$100 to start with \$100,000 added. Supplementary nominations may be made by the usual time of closing of entries for a fee \$625 which includes entry and start fees. After paying 1% to owners of horses finishing sixth through last, the remaining purse will be divided, 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of two races other than claiming, 2 lbs; of one race other than claiming, 4 lbs. Closed Friday, October 11, 2024, with 16 Nominations.

LIZ'S LEGACY bid in the four path on the turn and gained the place late. SPOOKY RIDGE stalked the pace inside, bid late and gained the show spot. SHE'S A WHIRLWIND stumbled at the start, stalked the pace inside, angled to the four path on the turn but had no bid. MISS CANDELA dueled outside and gave way in the stretch. CALCOLERY rallied in the three path and faltered in the stretch. DREAMING GIRL bumped with a foe at the start and raced well back. COOL D OR was off awkwardly and raced well back. SEEYOUINABIT dueled inside of a rival and gave way on the turn. SWEET HEAT bumped with a foe and was squeezed back at the start.
