HOOSIER DADDY NOW stalked the pace inside, bid three wide but was no match. KINGSBURY ROAD was unrushed early, rallied in the five path on the turn and couldn't close late. LEO SPRINGS stalked the pace inside, rallied at the three-eighths pole, dueled briefly in the stretch but couldn't last. THEO'SPROMISE stalked the pace in the three path, angled to the rail at the quarter pole and had no late bid. DATTTS LIFE was unrushed early and rallied late in the five path. IN CLINED and KNEEDEEPJUSTICE raced evenly. JAIL HOUSE JUSTICE and POSITIVE CHANGE saved ground to no avail. TREMOR dueled in the two path and gave way in the stretch. COSTLY PASS dueled inside and gave way on the far turn.
