By subscription of \$100 each, which should accompany the nomination or by supplementary nomination of \$3,000 by time of entry (includes entry and starting fees). \$750 to enter and an additional \$750 to start with \$150,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1.25% to each owner of horses finishing sixth through last, 62% of the remaining association purse will be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight 122 lbs. Non-winners of a graded sweepstakes allowed 2 lbs; a sweepstakes, 4 lbs. The maximum number of starters for the Myrttlewood will be limited to twelve. In the event that more than twelve horses pass the entry box, the twelve starters will be determined at that time by horses that have finished first, second or third in a graded or group stakes, non-restricted stakes winners, then condition preference. Starters to be named through the entry box by the usual time of closing. A set of two silver julep cups will be presented to the owner of the winner. Closed Wednesday, October 9, 2024 with 34 nominations.

E CHO SOUND stalked the embattled leading pair from the three path, tipped to the four path entering the lane, closed in on the clear leader nearing midstretch, bid while lugging inwardly leaving the furlong grounds, straightened course before taking charge at the sixteenth pole and drew clear. PRAYING brushed with an inner rival at the start before grazing a separate inner foe early on, pressed two wide, vied around the turn, drew clear in upper stretch, but was bested by an outer bidder in the final furlong and safely held place. TRUST FUND PHILL Y pursued from midpack in the three path into the turn, then between horses turning for home before swinging to the five path into the lane, rallied to gain show at the sixteenth pole and sustained gradual progress while holding that position late. DANCING MAGIC brushed with an outer foe and was off a step slow, trailed in the four path into the turn, advanced before fanning to the seven path into the lane, and rallied willingly. GLEE tracked along the inside, chased two wide and between horses in upper stretch, gained show at the furlong grounds but flattened out. ANDREA chased forwardly in the four path, floated to the six path into the lane and gave way. ATOMIC CITY bobbled at the start and shifted outwardly upon recovery, raced off of the pace along the inside, steadied hard behind a rival approaching the three furlong pole, shifted to the three path and between horses soon after, then failed to factor. MISCHIE VOUS BRIA broke a step slow, lacked speed in the two path and made little impact. WHITE SANDS brushed with an outer rival early on, set the pace inside of a sternly pressing rival, vied with that one around the turn, got headed entering the lane and weakened. BARBARINA chased while off of the pace in the two path and faded around the turn.
