FLORAS ORA dueled for the lead while two wide into the turn, was hard used then gave way in the stretch. LA CAMELIA was unhurried early and no threat. AFTERNOON DIVA dueled for the lead while inside, was used up then stopped in the stretch. OKIE MUSIC chased the early pace while inside into the turn, was shuffled back on the turn then stopped in the stretch.
