ARTISLAS steered over to the rail stalking early, bumped IVAN A GREAT while challenging through a tight spot on the fence leaving the far turn, dueled with IRON MAN CAL into the final furlong, drifted out in the final sixteenth while holding a slim advantage, bumped IRON MAN CAL at the wire and gamely prevailed. IRON MAN CAL showed early speed then took a stalking position in the two path on the clubhouse turn, was closest in pursuit up the backstretch and far turn, bid three deep into the stretch, dueled outside ARTISLAS down the lane, got floated out by that rival in deep stretch, dug in gamely while getting bumped between rivals at the wire and just missed. SABERT 00TH reserved in the early going and taken inside, crept closer on the backstretch, remained along the rail through the far turn, altered out midstretch, challenged three deep late, got bumped at the wire and missed in a blanket finish. KALE'S ANGEL lost his footing at the start, moved inside settling off the pace, ridden along continuing to save ground through the far turn, angled out in upper stretch and summoned a mild rally to round out the super fecta. R HEISMAN sat off the pace outside a rival came under a ride while shifted over to the three path on the far turn, moved out in upper stretch and failed to threaten. UNCLE EVCO tucked inside at the back, trailed to the stretch and passed tire drivals. IVAN THE GREAT took charge early from inside and cleared around the clubhouse turn, coaxed along on the farturn and remained unchallenged to the quarter pole, confronted by rivals on both sides while bumping with ARTISL AS entering the lane, lost command in upper stretch and weakened in the final furlong, CALI CAT showed early speed while pulling the rider along three deep, settled in a stalking position three then two wide on the first turn, chased three deep at the five-sixteenths pole and faded down the lane. FOLLOWING AN INQUIRY INVOLVING THE STRETCH RUN, THE STEWARDS DISQUALIFIED ARTISLAS FROM FIRST TO THIRD FOR DRIFTING OUT AND FORCING IRON MAN CAL INTO SABERTOOTH AT THE WIRE, COSTING BOTH RIVALS A CHANCE AT A BETTER PLACING.
