INTEGRATION settled nicely on the inside, was roused on the final turn, shifted to the two path into upper stretch, moved out outside the furlong marker and closed fast to blow by the embattled leaders late to win going away. LIMITED LIABILITY went three then four wide on the first turn, moved up on the outside down the stretch for the first time, stalked outside in the three path, was urged along on the final turn, turned into upper stretch on even terms for the lead, dueled with REBEL RED into the final sixteenth then bumped lightly and narrowly defeated that foe for the place but was overhauled by the winner. REBEL RED (GB) went four wide on the first turn, took the lead under tight restraint down the stretch for the first time, showed the way in the two path, was asked under threat late on the final turn, dueled with the runner-up into the final sixteenth, bumped lightly with a foe shortly thereafter and was also overtaken by the winner then just missed the place but was clear for the show. PIONEERING SPIRIT was taken in hand then rated inside to the two path, saved ground on the final turn, was asked at the quarter-pole then moved out in upper stretch and improved position for the last spot in the superfecta. CITY MAN went to the front while in hand, relinquished the lead under stout restraint down the stretch for the first time, was rated on the inside, went around the final turn in the two path, was roused outside the quarter-pole, came four wide into the stretch, chased under a drive into the final furlong and weakened. ADHAMO (IRE) settled in the two to three path, was asked on the final bend, came five wide into the stretch and lacked the needed kick. CURBSTONE saved ground at the rear, was coaxed along on the back stretch, raced inside under urging on the final turn and failed to rally. DAUNT went three wide on the turns, was roused on the final bend, came four wide into the stretch and lacked the needed response. MASTER PIECE (CHI) was hustled from the gate, settled in the two path, was urged along passing the half-mile pole, came three wide into the stretch and failed to respond. FOLLOWING A STEWARDS' INQUIRY INTO THE STRETCH RUN, NO CHANGE WAS MADE TO THE ORDER OF FINISH
